HERBY REQUESTS

To have exclusive/non-exclusive use (at my own risk and liability), the areas provided by Adria International Raceway track on the following days _____, in agreement that F&M S.r.l., reserves the right to modify or withdraw the right to use the track, at any time in the case of necessity also during tests.

The undersigned, regarding the above mentioned, declares:

1. To have inspected the state of the track, equipment and facilities of the circuit and confirm that they match up to requirements, and to relieve F&M S.r.l. from any property or non property damage liability consequences possibly caused by accidents that depend on the state of the track and equipment;
2. That on behalf of myself, my heirs and successors or involved entities, I hereby confirm to fully relieve F&M S.r.l. under any circumstances of liability against claims, demands, actions, suits, costs, reimbursements, or for any other reason which may be brought against or levied upon F&M S.r.l. in the case of any injuries however long its duration, results and relative consequences possibly required. Therefore, relieving liability for anything that may be the cause of injury on the track, from any person including the above mentioned firm, its organisation, its persons in charge and complete staff basically, any other interested component.
3. That on behalf of myself my heirs and successors or involved entities to fully relieve F&M S.r.l. from and against any claims, demands, actions, suits, costs, fines, penalties and proceeding which may be brought against or levied upon the underwritten by third parties for chargeable facts, including any persons participating in the event or not.

Following this preamble I further declare that:

4. To have consulted the norms and warnings to be observed using the assigned track and to unconditionally accept such norms and warnings;
5. To have consulted the fees and other operational conditions for use of track, and to unconditionally accept;
6. Regarding the above, the vehicle/motorcycle above mentioned is perfectly suitable for tests to be done by the undersigned;
7. To commit oneself, taking all responsibilities regarding civil and penalty rights for third or involved parties, to not give permission for other persons to move around the circuit with the above mentioned vehicle;
8. To commit oneself to wearing suitable clothing;
9. To be in perfect physical and physic health, relieving F&M S.r.l. from any liability for possible health problems that could occur while participating in the activity;
10. To be in possession of valid permits and/or driving licences;

Finally, I also declare:

11. To take full exclusive liability for any damage done directly or indirectly by the undersigned to the Adria International Raceway circuit structure of Adria or their staff. Relieving any responsibility due to the event at the present and at the time of event, and if verified in the above mentioned points.
12. That F&M S.r.l. is not responsible for theft and/or damages to material deposited in the circuit, take act that also the parking lots inside the circuit are unguarded.
